WHEREAS, an Engineering Report entitled Preliminary Engineering Report for the Wastewater Treatment System Improvements, dated June 2023 and revised December 2023, recommends implementing the Project to help improve water quality and protect public health: and

NOW THEREFORE BE IT RESOLVED, the Town of Byron Town Board identifies the Town Supervisor as the authorized representative of the Town to execute necessary documents relative to and as required for the grant application; and
