WHEREAS, the maximum amount proposed to be expended by the said district is Two Million Eight Hundred Fifty-eight Thousand Dollars (\$2,858,000.00). Of said amount, Five Hundred Thousand Dollars (\$500,000.00) is anticipated to be provided by a grant from United States Department of Agriculture Rural Development, and it is anticipated that there will be an annual cost to the typical owner of a one or two family home of One Thousand One Hundred forty-two and 59/100 Dollars (\$1,142.59) after the first year, and the first year cost to the typical owner of a one or two family home is anticipated to be Two Thousand Five Hundred Thirty-two and 59/100 Dollars

(\$2,532.59), both of which estimates include annual debt service and annual water usage costs, which will be levied upon each of the units in said District, and

WHEREAS, a petition in due form has been received and was filed in the Town Clerk's office on December 5, 2016 and which, according to an affidavit sworn to by Barry Flansburg, Town Assessor, contains the signatures of the owners of more than one-half of the total assessed value of the real property in said proposed district and more than one-half of the real property owned by persons residing in said proposed district, and which petition sets forth with specificity the maximum amount to be expended and anticipated the first year and subsequent annual cost for a typical one or two family home as above set forth,

ORDERED, that a meeting of the Town Board of the Town of Byron will be held at the Town Hall, Route 237, Byron, New York at 7:00 p.m. on January 11, 2017 to consider the Establishment of said Water District No. 8 of the Town of Byron, including the environmental significance thereof and to hear all persons present interested in the subject matter thereof, concerning the same and for such other and further action on the part of said Town Board may be necessary and proper, with relation to the premises.

Please review the attached memorandum Radon testing and Outreach from the Genesee County Health Department. After review please let me know if you would like me to hang up an informational poster in the Town Hall and also set out some additional information for the residents of Byron on this very serious health concern. (Memorandum dated December 23, 2016 from the Genesee County Health Department wherein Genesee County, NY has been identified by the EPA and the NYS Department of Health as having dangerous levels of radon gas concentrations in homes. Those tested averaged above the action level of 4 pCi/L (pico curies per liter) of air. No level of radon gas is safe and it can negatively impact people's health, especially if the concentration is elevated in a home. Testing a home for radon is the only way to know if high levels are present and corrective action can be taken. The Genesee County Health Department received a grant that will continue until June 30, 2020 and now offers services to educate the community and encourage all to take action. Home test kits, publications, and an education in-service are available at no charge to those who have a home in Genesee County Health Department).

**JCAP GRANT:** 

The Court received \$13,185 from the 2017 JCAP Grant. There is a construction amount of \$6,000 to make to court entrance door handicap accessible. At the present time, it is not ADA compliant. The remainder of \$7,185 will be used to improve the security of the courtroom. This includes a stand-alone, walk-through metal detector, a hand-held metal detector, and a new camera monitor on the bench showing all entrances and movement outside of the courtroom. The funds will also cover the cost of the Kevlar wrap for the bench area, which is becoming a requirement for court personnel protection. The funds will be transferred to the Town from JCAP by April 1, 2017, and we will be starting the construction and installation as soon as the funds are available.

# WATER DISTRICT NO. 8 SEQR – INTENT TO DECLARE LEAD AGENCY STATUS RESOLUTION #30:

The proposed action involves approximately 50,600 linear feet of 8-inch and 10-inch waterlines along portions of Cockram Road, Tripp Road, Ivison Road, Gillette Road, Freeman Road, Coward Road, Lyman Road, and Beaver Meadow Road in the Town of Byron. Depending on the budget, an additional approximately 3,200 linear feet of waterline may be installed along the portion of Ivison Road between Gillette Road and

Freeman Road as part of future efforts to provide reliable water supply infrastructure, and hence this area has been included in the environmental review. The project will provide public water to properties that are currently dependent upon individual groundwater supplies that historically have produced very low yields of poor quality water.

FURTHER RESOLVED, the Town Board has determined that, as portions of the project are located within a Genesee County Agricultural District, the proposed action is a Type I action as

defined under SEQR; and, be it
