# RESOLUTION AMENDING THE CONTRACT WITH BYRON FIRE DEPARTMENT NO. 1 INC. FOR FIRE PROTECTION, EMERGENCY MEDICAL AND AMBULANCE SERVICES BY INCREASING THE COMPENSATION BY \$30,000 TO A TOTAL OF \$135,000 RESOLUTION #34:
