WATER DISTRICT NO. 6 - AWARD OF BID FOR CONSTRUCTION

RESOLUTION #76:

Supervisor Yasses made the following resolution and moved for its adoption:

WHEREAS, the time established for the opening of the bids for the construction of the facilities for Water District No. 6 in the Town of Byron, Genesee County, New York having arrived, and

WHEREAS, ten (10) sealed bids having been received and opened, and

WHEREAS, those bids having been tabulated by Paul Chatfield of Chatfield Engineering, and

WHEREAS, it having been determined that the lowest responsible bid was submitted by Randsco Pipeline, Inc. in the amount of \$594,420.00;

NOW THEREFORE, be it

RESOLVED, that Randsco Pipeline, Inc. is hereby awarded the contract to construct the water main and appurtenant structures for Water District No. 6 in the Town of Byron, Genesee County, New York at a cost not to exceed \$594,420.00, subject to and upon its execution of the written contract

drafted by the said engineers and approved by the Town Attorney and the posting of the required Performance Bond in the amount of \$594,420.00.

Councilwoman Fuller seconded the resolution which was adopted by the following vote:
