LEGAL NOTICE SPECIAL MEETING TOWN OF BYRON

PLEASE TAKE NOTICE, that the Town Board of the Town of Byron will hold a Public Hearing on Wednesday, November 7, 2018 regarding Local Law entitled, "Local Law No .1 of 2018 – Authorization of the Town Board to Override the Tax Levy Limit Established in General Municipal Law 3-c" at 7:00 p.m. at the Byron Town Hall, 7028 Rte. 237, Byron, New York. A summary of the law is as follows:

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Byron pursuant to General Municipal Law §3-c, and to allow the Town of Byron to adopt a budget for the fiscal year 2019 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

The full text of the Proposed Local Law No. 1 of 2018 is on file at the office of the Town Clerk and is available for inspection

during regular office hours.

Local Law No. 1 of 2018 Town of Byron County of Genesee

A Local Law to override the tax levy limit established in General Municipal Law 3-c

Section 1 Legislative Intent

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Byron pursuant to General Municipal Law §3-c, and to allow the Town of Byron to adopt a budget for the fiscal year 2019 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2 Authority

This Local Law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a Local Law approved by vote of sixty percent (60%) of the Town Board.

Section 3 Tax Levy Limit Override

The Town Board of the Town of Byron, County of Genesee, is hereby authorized to adopt a budget for the fiscal year 2019 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law §3-c.

Section 4 Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5 Effective Date

This Local Law shall take effect immediately upon filing with the Secretary of State.

HIGHLIGHTS OF THE 2019 PRELIMINARY BUDGET:

- •Amount to be raised by taxes is General Fund: \$200,000; Highway Fund: \$282,725
- •General and Highway Funds: the tax rate is \$4.3072/1,000, up \$.8846 from 2018
- •Sewer District: \$0 to be raised by taxes. O&M to remain at \$100/unit/quarter (\$400/year), and debt service will be \$0. There are 315.50 units.
 - •Water District #1: \$90,000.00 to be raised by taxes (301.60 units)
- •Water District #2: \$72,541.00 to be raised by taxes, with the Town of Byron having 164.20 units, and the Town of Stafford having 28 units
 - •Water District #3: \$5,293.00 to be raised by taxes (9.10 units)
 - ·Water District #4: \$4,855.00 to be raised by taxes (11 units)
 - ·Water District #5: \$19,147.00 to be raised by taxes (55.50 units)
 - ·Water District #6: \$9,527.00 to be raised by taxes (29.50 units)
 - ·Water District #7: \$25,249.00 to be raised by taxes (65.50 units)

•There was a discussion regarding the Fire District budget: The Town Board will be budgeting \$100,000 for each fire department for 2019. There was also a discussion regarding fit testing and the new cancer bill.

PUBLIC COMMENTS: John Sackett – asked why interest income was so low, and also would like to know how many years are left for debt service on Water District #1 and why money from fund balance wasn't used to lower amount of debt service.

Supervisor Rouse – interest income could be low because CDs were opened last year when rates were lower and now the Town is using an investment firm. There is 3 years left for the debt service for Water District #1.
