ASSESSOR'S REPORT:

•Reviewed the assessment growth in the Town of Byron since 2006. 10% of taxable value of town is in state valued property that has not grown since 2006. Of the remaining 90%, residential makes up 80% of that number. Town has seen slow but steady growth. Rural towns will not see great increases in value from one year to the next. Policies should keep the rural aspect intake and values will hold in the future.

•Annual aid payments for assessment purposes have been cut by the Governor by 14.5% so far. Byron was to receive assessment aid and consolidation aid with Oakfield for 2009 totaling \$12.00 per parcel. That will now be \$10.26 per parcel if it is paid at all. Earliest 2009 aid may arrive is March 2010. Byron is one of 19 municipalities in New York that has done annual reassessment since 1999 and has received over \$50,000 in aid over that

time. Anne Sapienza started the process that I am continuing. Future of state funding will be in question for the future. Many costs will be at town expense with no state funding.

WHEREAS, after a public hearing duly called and held on May 14, 2008, the Town Board of the Town of Byron (the "Town Board" and the "Town," respectively), in the County of Genesee, New York, duly adopted a resolution and order determining that it is in the public interest to increase and improve the facilities of Water District No. 4 (Cockram Road) in the Town (the "District"), consisting of the installation of 2,150 lineal feet of water mains and eleven (11) lateral connections on Cockram Road in the Town of Byron and and including land or rights in land, furnishings, equipment, machinery and apparatus required

therefor, and ordering that the facilities of the District be so increased and improved at an estimated maximum cost of \$156,000.00, and

WHEREAS, due to generally increased costs of labor and materials, the maximum amount now proposed to be expended for said improvement of the water system is \$191,000.00, being an increase of \$35,000.00, and

WHEREAS, on November 11, 2009, the Town Board of the Town adopted an order describing in general terms said increase and improvement of facilities at the revised estimated maximum cost of \$191,000.00 and stating that the Town Board would meet to hear all persons interested in said increase and improvement of facilities at said revised estimated maximum cost on November 24, 2009, at 7:00 p.m. at the Town Hall;

WHEREAS, copies of said order certified by the Town Clerk were duly published and posted pursuant to the provisions of article 12 of the Town Law;

WHEREAS, such further public hearing was duly held, after a copy of such order certified by the Town Clerk was duly published and posted, at the time and place as stated in such order and considerable discussion on the matter having been had and all persons desiring to be heard having been heard in favor of and in opposition to said increase and improvements of facilities at the revised estimated maximum cost; now, therefore, upon the evidence given at such hearing, it is hereby

RESOLVED AND DETERMINED, that it is in the public interest to increase and improve the facilities of the District as hereinabove described and referred to, and it is hereby ORDERED, the facilities of the District shall be so increased and improved at a cost not to exceed \$191,000.00, the amount stated in the notice of hearing as the revised estimated

cost of such increase and improvement of facilities; and it is further

ORDERED, that the expense of said increase and improvement of facilities shall be assessed, levied and collected from the several lands or parcels of land within the District, so much upon and from each as shall be in just proportion to the amount of benefit which the Town Board determines said increase and improvement of the facilities shall confer upon the same, and any amounts received from grants of federal and state funds shall be applied to the cost of said increase and improvement of facilities, or toward redemption of any bonds issued therefor or budgeted as an offset to assessments for payment of the principal and interest thereon, and it is further

ORDERED, that the Town Clerk record a certified copy of this resolution and order after public hearing in the office of the Clerk of Genesee County within ten (10) days after adoption thereof, and it is further

ORDERED, that because the cost to a typical resident will exceed the threshold of the average cost for water districts established by the Office of State Comptroller that this resolution and order shall not be effective unless and until permission is received from the Office of the State Comptroller.
