## **PLANNING BOARD REPORT:**

·Appointment of Planning Board Member: There is an opening on the Planning Board due to the departure of Brenda Miller at the end of her term (12/31/13). The Town Clerk put a notice in the Daily News for interested persons, and the only application received was from Jim Lamkin.

A **motion** was made by Councilman Thompson to appoint James Lamkin as a member of the Planning Board for a five year term. The motion was seconded by Councilman Austin and carried with the following vote:

·The Planning Board received an application for a rezone from Fred Johnson with detailed information for use of the property located at 6815 Rte. 237 (Tax Map No. 5-1-39), which he is interested in purchasing from UMMC. Mr. Johnson would like to convert the property to a residential property, however, he would also like to have an assisted living facility located on the premises.

·The Town Board also received a petition from Fred Johnson of LeRoy, requesting that the Town Board change the zoning from a C-1 District to an R-1 District on the parcel prior to purchasing it.

·Planning Board Chairman Eric Zuber advised the Town Board that the Planning Board is very receptive to having the property rezoned from C-1 to an R-1 District. The adjacent property is in an R-1 District.

·CEO/ZEO Ken Kuter stated that Mr. Johnson is acting as an agent for UMMC right now because UMMC is still the property owner. Mr. Johnson's sister will be living at the property with her family, and she would also like to have an assisted living facility on the premises.

·Mr. Johnson stated that they will be able to take in up to 6 persons who need assistance. They will be providing meals, laundry and personal assistance. No certification is needed to do this, but it will be regulated. There will be a social worker that will be supervising the home on a regular basis.

·Town Attorney Paul Boylan would like the Town Board to know that he represents both the Town of Byron and UMMC. If there is any type of disagreement between the parties, he will need to recuse himself from representing either party. If the Town Board would like to move forward, they will need to accept the Planning Board's recommendation, make a resolution to act as lead agency, and have Paul start the SEQR process. The Board would also need permission from Genesee County Planning in order to change the property use. A Public Hearing will be set up after recommendation from County Planning.

## **LEAD AGENCY DESIGNATION**

Attorney Paul Boylan: He would suggest that the Planning Board begin by reading through the Comprehensive Plan first to see whether it needs to be updated or completely redone.

Councilwoman Fuller: The Fracking Committee would like to have an attorney that is proficient in fracking review the Zoning Law and Comprehensive Plan to make sure they relate to each other correctly.

Supervisor Yasses: He does not believe that is necessary at this time.

- Switched valving in each filter bed to give one section a rest. Three sections of treatment per bed. One section is always off line.

**HIGHWAY SUPERINTENDENT'S REPORT: – Superintendent Heins**

- Routine maintenance on truck repairs and plowing equipment
- Using sand and salt mix during cold snap for control of ice and snow on roads as well as saving on salt usage. The salt deliveries are slow with all the bad weather in the east and south.
- Pushing back troublesome snow banks for additional snow storms.

·When weather breaks there are several trees and continued roadside brush to be cut and chipped.

·Town Clerk wants more storage space for the town records to be moved out of the safe that took 50 years to fill. I suggested the sewer office space, and that office be moved to highway office, where there is room for two of everything (desk, computers, phones and the five file cabinets). There is also extra room for additional storage for parts and pumps in highway office. The Town Clerk asked me if the Highway men could do the upgrade work, and I assured her that we could certainly provide the labor to fire proof the sewer office with fire rated wallboard, install fire door, and block in the window. It would be a HUGE cost savings to the town to use the town workforce, and provide adequate space for years, as it has taken 50 years to fill the safe and this records storage room will have room for years beyond that time, and hopefully a better facility for the judges and clerk will be here. To knock down walls and move doors and rebuild walls and cramp the office space in the sewer office would not be a cost savings to the town with or without a grant. There is just as much needed storage for sewer and highway records as town records, and they need to be readily available to the sewer and highway workers for information, and there is the space in the highway office for these records.

#### **SAFE:**

·Per the Town Clerk, the safe space needs to be increased due to records being stored in areas that are not fire safe. For Stuart Brown's office to do application for grant for vault it will cost \$2,250. Two options are available: #1 would be to expand the current safe location into the Highway Superintendent's office, and #2 would be to turn the existing sewer office into a fire safe vault. Need to know how the Town Board would like to proceed? Do we apply for a grant and spend the \$2,250 and possibly not get the grant, or does the Town take the money out of the Buildings Account and do it without the grant? If the Town Board wishes to move forward with a grant they will need to pass a resolution allowing Stuart Brown's office to proceed with the application.

·After some discussion, the Town Board decided they would like to have Stu Brown's office tell them what the best space to use for the safe would be, and move forward according to what Stu Brown's office recommends.

WHEREAS, the proposed improvements consists of the installation of approximately 19,700 linear feet of water main, hydrants and other appurtenances, and

WHEREAS, the maximum amount proposed to be expended by the said district is One Million One Hundred Forty-seven Thousand Dollars (\$1,147,000), and it is anticipated that there will be an annual cost to the typical owner of a one or two family home of Six Hundred Forty-eight and 86/100 Dollars (\$648.86) after the first year, and the first year cost to the typical owner of a one or two family home is anticipated to be One Thousand Five Hundred Three and 86/100 Dollars (\$1,503.86), both of

which estimates include annual debt service and annual water usage costs, which will be levied upon each of the units in said District, and

WHEREAS, a petition in due form dated September 13, 2013 has been received and filed in the Town Clerk's office and which, according to an affidavit sworn to by Barry Flansburg, Town Assessor, contains the signatures of the owners of seventy-three percent (73%) of the total assessed value of the real property in said proposed district and seventy-three percent (73%) of the real property owned by persons residing in said proposed district, and which petition sets forth with specificity the maximum amount to be expended and anticipated the first year and subsequent annual cost for a typical one or two family home as above set forth,

**HIGH SPEED RAIL:**

·Received a letter regarding the proposed high speed rail system, which will run from Niagara Falls to NYC. There are five different proposed project systems. There will be public hearings on March 6, 2014 in Buffalo, and March 7, 2014 in Rochester. The most expensive proposal would cost \$14.71 billion to be finished by 2035. There are other options that will not cost as much or affect as much of the County. The system would either go down the old West Shore Trail or alongside the existing railroad. As per Jeanne Freeman, printed copies of the proposals are available at the Richmond Memorial Library. The Town Board will keep the public updated as information becomes available.
