Felipe Oltramarri, Genesee County Planning

Jim Krencik (GCEDC) described what PILOT is: An agreement that allows a project that is growing, launching or relocating to have start-up costs covered for a set term, usually 10 years. The company would pay partial taxes and then increase to full taxes by the 10th year. In this case it is a different type of project. The GCEDC represents the Town and helps the Town to make sure they don't have to bear the costs. It would help the Town, school district and County to make sure there is a benefit to all the parties.

Felipe Oltramarri (GC Planning) - Article 10 Project: Felipe handed out an overview of the process (attached). Article 10 takes citing out of the jurisdiction's hands. The Town should rely on the Town attorney for guidance.

JP Schepp (MRB Group) – MRB Group is the engineering firm for the Caledonia and Mt. Morris solar projects, which projects are a little further along. Article 10 application has not been made for this project yet. Public participation and open houses have been done for Mt. Morris already. Caledonia has not done either yet. It is very early in this project.

Dean Ivison – he would like to know where it's going to be.

Councilwoman Sue Fuller – any studies done for long term plans?

JP Schepp – there are going to be thorough environmental reviews.

Eric Zuber – Where will public hearing be held?

JP Schepp – informational meetings will be local. Citing board may be in Albany.

Town Attorney, Paul Boylan – Everything has to be done within 2 miles of the project

Supervisor Rouse – Please leave any questions with the Town Clerk and the Town will try to answer them.

Steve Hohn – can there be multiple companies going together to form solar farm?

JP Schepp – his experience is that there's usually just one.

RESOLUTION #34:

WHEREAS, it has come to the attention of this Town Board that there is an error in the meets and bounds description of the area intended to encompass Water District No. 7 whereby property owners on Route 262 were excluded from the boundary description in the "Resolution for Establishment of Water District No. 7 After Public Hearing", and

WHEREAS, this Board is in receipt of a Petition signed by the sole resident and all but one of the non-resident owners of property in the excluded area requesting that the district be extended and that therefore one hundred percent (100%) of the resident owners and more than fifty percent (50%) of the owners in the excluded area are in favor of being included in Water District No. 7, and

WHEREAS, there will not be an increase in the maximum amount to be expended nor an increase in the debt service to be paid by the owners nor an increase in the amount included in the contract bid for the construction of the improvements in the district, and

WHEREAS, as it was the intent of this Town Board and a majority of the owners and resident owners to include those owners mistakenly excluded as evidenced by the recitation in the said Resolution that the description was to be "All as shown on a map prepared by Chatfield Engineers, P.C., entitled, "Town of Byron Water District No. 7, Water District Boundary Map", dated February 16, 2016", which map included those said properties,

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Byron that the "Resolution for Establishment of Water District No. 7 After Public Hearing" adopted on June 15, 2016 is hereby corrected to recite the description as set forth on the Boundary Description dated February 17, 2016 and attached hereto, and

BE IT FURTHER RESOLVED, that as so corrected said "Resolution for Establishment of Water District No. 7 After Public Hearing" is hereby ratified and confirmed.

PUBLIC COMMENTS:

Councilwoman Sue Fuller – The Town is very concerned regarding Water District No. 7 and the proposed solar farm.

Aaron Sharp – Should the town do a moratorium for the solar farm?

Paul Boylan - The Town already has a solar law in place from 2016 allowing solar farms. A moratorium won't do any good at this point. The Town needs to form a committee to get as much information as you can regarding the pros and the cons. He does not know what benefit package they're going to offer, but it may be worth it to the Town to see what they are going to offer the Town. The fee that the solar company pays to the board is used to pay for the employment of legal and expert representation.

Councilman Fred Klycek – the state is making the decision

Barb Starowitz – Transit Road Water District – options for getting water to her property.

Jeff Thompson – It is Elba's water district, not Byron's. Byron can't tap into Elba's water without their permission. The Town is working on a district for Byron.

Article 10

Major electric generating facilities larger than 25 MW are sited according to New York State's Article 10 law. This comprehensive law provides guidance to the New York State Board on Electric Generation Siting and the Environment (Siting Board) about authorizing construction and operation of major electric generating facilities. The Article 10 law streamlines the application process for developers, while providing a rigorous process for local input and ensuring environmental and public health laws are followed. The public can participate in the Article 10 decision-making process by offering support, voicing concerns, or asking questions about public health, safety, the environment, and other factors. This process begins during the initial planning of the facility and continues throughout the siting review, construction, and operation.

Article 10 Process

Step 1: Public Involvement Program

Developers are required to implement public involvement programs in the respective communities at least
 150 days before submitting their preliminary scoping statement and official applications to the Siting Board.

Step 2: Preliminary Scoping Statement

 The preliminary scoping statement is a written document informing the Siting Board, other public agencies, and the community about the project, including a description of the proposed facility, potential environmental and health impacts, proposed studies to evaluate those impacts, proposed mitigation measures and reasonable alternatives to the project.

Step 3: Formal Application

 After the public involvement program and preliminary scoping statement are filed, developers must then submit a formal Article 10 application to the Siting Board, which includes the same information as the preliminary scoping statement but in greater detail.

Step 4: Siting Board Decision

• The Siting Board must make its final decision about whether to issue or deny the certificate within 12 months of the date that a developer's application is deemed complete.
