PLANNING BOARD REPORT - Councilwoman Fuller:

Chairman Sharp suggested that the Planning Board meet only as needed for Town business, but not to work on the Comprehensive Plan. ·Supervisor Yasses would like to have Councilwoman Fuller and Councilman Cudney reiterate to the Planning Board that the Town Board would like them to continue meeting to work on the Comprehensive Plan even if there is no Town business before them. Supervisor Yasses will try to attend the next Planning Board meeting to discuss this issue.

HIGHWAY SUPERINTENDENT'S REPORT:

- ·Salt usage is at an average year, but with more sand and salt mix use during cold weather.
- •Equipment repairs has been minimal for the amount of times trucks have been plowing since November 17th February 28th. 158 trips on each truck.
- ·A water line froze to a house on Townline Road on February 25th and was 5 days before Monroe Water was able to thaw it. Frost down 53 inches under bare roads.
- ·Town wide fire hydrants were kept clean by Highway Department when not plowing roads. Thankfully hydrants did not have to be used.
- Expenses and income at transfer station has left the department at a plus \$1,600. The sticker system works very well and is holding Town costs down.

Supervisor Yasses: Reports to the state are up-to-date.

Councilman Thompson: George and the highway men cleared the ditches on Swamp Road of snow because of drainage issues, and they did a good job because it has taken care of the problem.

WATER DISTRICT NO. 5:

Bid opening was on February 25, 2015 with Highlander submitting the winning bid of \$772,160.00, which amount was \$148,600.00 less than the projected budget amount.

A portion of Hessenthaler Road is private property (Bergen Swamp Society), and not Town property. The Town needs a signed easement to put water line on private property. The Bergen Swamp Society does not meet until Tuesday, March 17th, so the Town can't get approval until then. There should not be an issue with them signing the easement. Therefore, the Town can't award the bid to Highlander until the easement is approved by the Bergen Swamp Society. The Supervisor would like to hold a special meeting on March 20th at 4:00 p.m.

LaBella Associates, D.P.C.'s fee for such work shall be \$2,500.00 for the preparation and submission of the Final Rural Development Application.

FIRE DISTRICT INFORMATIONAL MEETING:

The Byron Town Board held another Informational Meeting on Monday, February 16, 2015. Attendance was still very poor even though letters were sent out to all property owners. It was another very informative meeting. Supervisor Yasses believes that neither fire department knew exactly what a fire district entailed, however, after these meetings they don't believe a fire district would be the best way to proceed. After speaking with the Supervisor this past Monday night, both fire departments have decided to continue on as they have been, working with the Town to create a budget that is acceptable to both departments and the Town Board. Both companies had a problem with needing to

sign over everything to the fire district, and therefore, the fire companies would like to keep everything the way it is now at least for the next 18 months. Supervisor Yasses would like Councilwoman Fuller and Councilman Thompson to be liasons to the fire departments and come back to the Town Board with quarterly reports. He believes the Town needs to know what the fire departments do and what their needs are, and the fire departments need to know where the Town stands and what their reasoning is. Supervisor Yasses would like to see the \$10,000.00 that was taken away from each department returned to them in the 2016 budget.
