# <u>HIGHWAY SHARED SERVICES AGREEMENT</u> RESOLUTION #33:

Councilman Cudney offered the following resolution and moved for its adoption:

**Resolved,** that the Byron Town Board authorizes the Town of Byron Supervisor to sign an agreement on behalf of the Town of Byron which authorizes the Supervisor to directly contract with the Superintendents of persons holding similar public office in other municipalities who possess similar authorization for borrowing or lending of materials and supplies and the exchanging, leasing, renting of machinery and equipment, including the operators thereof, for the purpose of aiding the Superintendent in the performance of his/her duties.

**WHEREAS**, all municipalities, including the Town of Byron, have the power and authority to contract for the purpose of renting, leasing, exchanging or borrowing of machinery and equipment, with or without operators, with other municipalities, and

**WHEREAS**, all municipalities, including the Town of Byron, have the power and authority to borrow or lend materials and supplies to other municipalities, and

**WHEREAS**, it is hereby determined that the Town of Byron and other municipalities have machinery and equipment which is not used at all times, but lie idle during certain periods, and

**WHEREAS**, it is determined that the Town of Byron and other municipalities often have materials and supplies on hand which are not immediately needed, and

**WHEREAS**, it is hereby determined that by renting, borrowing, exchanging or leasing of highway machinery and equipment and the borrowing or lending of materials and supplies, the Town of Byron and other municipalities may avoid the necessity of purchasing certain needed highway machinery and equipment and the purchasing of or keeping of a large inventory of certain extra materials and supplies, thereby saving the taxpayers money, and

**WHEREAS**, it is recognized and determined from a practical working arrangement, that no program of borrowing, exchanging, leasing or renting of highway machinery and equipment or borrowing or lending of materials can be successful if each individual arrangement or agreement has to

receive prior approval by the Town Board and the governing board of each of the municipalities, which may be made on short notice and at times when governing boards are not in session, and

**WHEREAS**, it is incumbent upon each municipality to design a simple method whereby materials and supplies, equipment and machinery, including the operators thereof, may be quickly obtained with a minimum of paperwork and inconvenience and with a swift approval process, and

**WHEREAS**, it is the intent of this Town Board to give the Supervisor the authority to enter into renting, exchanging, borrowing and lending agreements with the persons serving in similar capacities in other municipalities without the necessity of obtaining approval of the Town Board prior to the making of each individual agreement, and

WHEREAS, a standard contract has been prepared which is expected to be adopted and placed into effect in other municipalities which contract will grant the person holding the position capable to that of the Highway Superintendent authority to make similar agreements, and

**WHEREAS**, it is hereby determined that it will be in the best interest of the Town of Byron to be a party to such an agreement,

**NOW THEREFORE BE IT RESOLVED**, that the Supervisor of the Town of Byron is hereby authorized to sign, on behalf of the Town of Byron, the Highway Shared Services Agreement which shall be effective on the date of signing, and be it further

**RESOLVED**, that the Highway Superintendent of the Town of Byron is authorized and directed to file a copy of the Highway Shared Services Agreement with the Supervisor/Mayor and Superintendent of Highways/Supervisor of Public Works of each municipality/government agency within the County of Genesee and neighboring counties.

# APPROVAL OF ACQUISITION OF EASEMENTS BY THE MONROE COUNTY WATER AUTHORITY PURSUANT TO \$1096(6-A) OF NEW YORK'S PUBLIC AUTHORITIES LAW RESOLUTION #36:

Councilman Klycek offered the following resolution and moved for its adoption:

WHEREAS, the Monroe County Water Authority (the "Water Authority") intends to expand and construct a water main (the "Project") to bring the Water Authority's supply to the property owners on North Byron Road and Cockram Road; and

**WHEREAS**, the acquisition of one (1) easement by the Water Authority is necessary for the construction, installation, operation, and maintenance of the Project; and

**WHEREAS**, the easement necessary for the Project is located along the frontage of 6329 Cockram Road (approximately 20 feet x 10 feet), the parcel with a Tax Account Number 7.-1-86.111, which is owned by Gina Lippa; and

**WHEREAS**, the acquisitions are necessary to allow the completion of the construction, installation, operation, and maintenance of the Project which will provide potable water supply and fire protection to the District's property owners; and

**WHEREAS**, Section 1096(6-a) of New York's Public Authorities Law requires the Water Authority to obtain the prior approval of the above-referenced acquisitions by resolution of the Town Board.

#### NOW, THEREFORE, let it be

**RESOLVED**, that the Town hereby approves of the Water Authority's acquisitions of all necessary easements within the Project in accordance with §1096(6-a) of the New York Public Authorities Law and be it further

**RESOLVED**, that a copy of this Resolution be provided to the attorney for the Town and Water Authority.

# WATER DISTRICT NO. 7 SEQR-INTENT TO DECLARE LEAD AGENCY STATUS RESOLUTION #38:

Councilman Thompson offered the following resolution and moved for its adoption: *RESOLVED*, that in accordance with the New York State Environmental Quality Review (SEQR) regulations, the Town Board of the Town of Byron hereby announces its intent to serve as Lead Agency to conduct an environmental review of the construction of public water supply improvements to serve the Town of Byron Water District No. 7. Approximately 38,200 linear feet of waterline will be installed along portions of Batavia-Byron Road, Walkers Corners Road, Caswell Road, Cockram Road and Rte. 262 in the Town of Byron. The project will provide public water to properties that are currently dependent upon individual ground water supplies that historically have

**FURTHER RESOLVED**, the Town Board has determined that, as portions of the project are located within a Genesee County Agricultural District, the proposed action is a Type I action as defined under SEOR; and, be it

**FURTHER RESOLVED**, the Town Board acknowledges that Part 1 of the Environmental Assessment Form has been prepared for this project by Stuart I Brown Associates, Inc., and signed by the Town Supervisor, and be it

**FURTHER RESOLVED**, the Town Board will notify the Involved Agencies of its intention to act as Lead Agency for this project and will provide them with a copy of Part 1 of the full Environmental Assessment Form for review during the 30-day comment period.
