### **HIGHWAY SUPERINTENDENT'S REPORT:**

- ·New salt bid for 2015-2016 shows an increase of \$5.66 per ton. Town uses approximately 2500 ton per year.
  - ·Stockpiling materials for summer road work.
- ·Loader replacement should continue to be a Caterpillar as the front fusion coupler on Town loader has attachments that fit only this coupler (snow plows, front forks, buckets). Caterpillar equipment has a higher resale or trade in value. The hourly trade in offer every year is the \$10.00 per hour meter hours plus machine price increase. Could be around \$4,000-\$5,000 total per year. Town loader now is showing inside cab rust, and the floor pedals have been replaced due to salt and tire replacement cost of \$10,000. Probably in next years expenses. This state bid price will be discontinued after the present contract expires in October 2015. This is a very generous offer for the Town to take advantage of and be responsible to Town taxpayers.
  - ·Roadside mowing has been completed for the first time.

**Supervisor Yasses:** The Machinery/Equipment Committee will need to meet to review options for the purchase of a new loader.

# AMENDMENT B TO STATE SNOW AND ICE AGREEMENT **RESOLUTION #53:**

*NOW*, *THEREFORE*, *BE IT RESOLVED*, to authorize the Town Supervisor to execute an Amendment to the present Agreement. Said Amendment would increase the estimated cost to perform snow and ice control for the 2014/2015 season by \$10,085.10.

### **SURVEILLENCE CAMERA QUOTES:**

Received quotes from three vendors last month. V2D Tech was the high bidder and didn't believe he could reduce his bid. The Town Board heard from Action Security last month and Jim Russell is making a presentation this evening.

### **PURCHASE OF SECURITY CAMERAS**

The only differences in the generators are that Dan quoted a standard generator, and the others quoted a more industrial generator, which the Town really doesn't need.
