#### **MUSEUM REPORT – Councilwoman Fuller:**

## **SUPERVISOR'S REPORT:**

Received Mortgage Tax Payment in the amount of \$13,757.94, which is \$3,757.94 more than was budgeted for 2016

·Games of Chance Law – need to set up a Public Hearing for August to do Local Law and then it will be put on the November General Election ballot for a vote.

A <u>motion</u> was made by Councilwoman Fuller to call a Public Hearing on Wednesday, August 10, 2016 at 7:00 p.m. to establish Local Law No. 2 of 2016 authorizing Games of Chance by

authorized organizations within the Town of Byron. The motion was seconded by Councilman Klycek and carried with the following vote:

·Sales Tax Allocation Agreement with the County – a committee has been formed by the County in order to review the current agreement and the County's options with the Towns in Genesee County. Original Agreement was between the County and the City of Batavia.

·Workers Compensation Rate Increase – spoke with Lawley and they do not have any numbers for a premium until later this week.

·Health Insurance – the Supervisor met with a representative from Bene-Care and was told that the Town's current coverage Univera ValUcare Plus Silver 4 is no longer available, and that the Town would need to look at different options. After speaking with the Highway Department employees, it was decided they would switch to BCBS of WNY Gold PPO 7100 HSAQ, and that \$1,750 would be put into their HSA account (\$1,300 annual deductible for a single plan). It has to be decided prior to Friday.

•The Highway Superintendent also spoke with the Highway Department employees and they are not in agreement with the \$1,750.00 for their HSAs now. He believes the Town will be in violation of the Taylor Law if they put a dollar amount on the HSA because it would be a change in the current union contract without approval from the union employees.

·After some discussion, it was decided that at this time the Town Board would agree to not put a dollar figure on the HSAs until the amount is negotiated with the union employees.

A <u>motion</u> was made by Councilman Klycek to change the health insurance coverage for Town employees from Univera ValUcare Plus Silver 4 to BCBS of WNY Gold PPO 7100 HSAQ. The motion was seconded by Councilwoman Fuller and carried with the following vote:

#### **OTHER BUSINESS:**

#### WATER DISTRICT NO. 5 & 6:

•The Town Board needs to pass a resolution increasing the legal services budget items for Water District Nos. 5 and 6. There were extra legal fees required by the Town Attorney for problems that arose in the districts. It will not cost the users any more money because the money will come out of the grant funds.

·Councilwoman Fuller will not agree to pay the Town Attorney more money because it should have been included in the original agreement.

·The Supervisor will ask Mr. Boylan to submit a detailed bill.

The Agreement for Water District No. 5 states attorney fees will be \$190/hr., not to exceed \$13,000. The Agreement for Water District No. 6 states attorney fees will be \$200/hr. with no not to exceed clause.

# WATER DISTRICT NO. 7 – SEQR RESOLUTION - NEGATIVE DECLARATION RESOLUTION #57:

Councilman Klycek offered the following resolution and moved for its adoption: *WHEREAS*,

- 1) In accordance with the New York State Environmental Quality Review regulations (SEQR), the Town Board of the Town of Byron announced its intent to serve as Lead Agency on May 11, 2016, to conduct an environmental review of public water supply improvements within the Water District No. 7 service area. The project will ensure a safe and reliable potable water supply and fire protection for area residents and businesses.
- 2) The Town Board has determined that the proposed action is a Type I action as defined under SEQR, as portions of the project are located in a Genesee County Agricultural District.
- 3) The Town Board, in its capacity of Lead Agency, has caused to be prepared an environmental assessment of the significance of and potential environmental impact of the action described above.
- 4) On May 19, 2016, the Town Board notified the Involved and Interested Agencies of its intention to act as Lead Agency for this project and circulated Part 1 of the full Environmental Assessment Form. None of the Involved Agencies objected to the Byron Town Board serving as Lead Agency for this project. The Town will obtain all necessary permits and approvals from Involved Agencies and will comply with agency requirements.
- 5) The Town Board has considered the Environmental Record prepared for this action, including any comments received from the Involved Agencies, and the proposed Negative Declaration.

## NOW THEREFORE BE IT RESOLVED,

The Town Board of the Town of Byron declares that it will serve as Lead Agency for the water system improvements proposed in Water District No. 7; and,

The Town Board declares that, based on the Environmental Record which has been prepared, the project will not result in any large and important impacts, and therefore, will not have a significant adverse impact on the environment. A Negative Declaration under SEQR is therefore issued for this project, and the Town Supervisor is hereby authorized and directed to prepare and issue, on behalf of the Town, the form entitled "Negative Declaration Notice of Determination of Non-Significance."

# <u>WATER DISTRICT NO. 7 – LATERAL RESTRICTIONS RESOLUTION</u> RESOLUTION #58:

Councilman offered the following resolution and moved for its adoption:

**WHEREAS**, the Town Board of the Town of Byron has created the Town of Byron Water District No. 7 pursuant to Town Law for the express purpose of providing public water supply to residents along portions of Byron Elba Road (State Hwy 262), Caswell Road, Walkers Corner Road (Co Rd 19), Batavia Byron Road (Co Rd 19A), and Cockram Road; and

WHEREAS, part of the land area within Water District No. 7 is also within Genesee County Agricultural District No. 4; and

**WHEREAS**, the Town Board has filed a Notice of Intent to Undertake an Action Within an Agricultural District to evaluate the impact of providing a source of public water supply within this area on lands within Agricultural District No. 4; and

**WHEREAS**, the New York State Department of Agriculture and Markets ("Department") has expressed concern about the potential adverse impact that said public water supply is likely to have on agriculture within the Agricultural District,

**NOW THEREFORE BE IT RESOLVED**, that the Town Board, in recognition of the concerns that have been raised, hereby resolves to adopt the "Lateral Restriction - Conditions on Future Service" specified by the New York State Department of Agriculture and Markets as follows:

# **Lateral Restriction - Conditions on Future Service**

The Town of Byron imposes the following conditions, as warranted or recommended on the management of water/sewer lines located along the portions of Byron Elba Road (State Hwy 262), Caswell Road, Walkers Corner Road (Co Rd 19), Batavia Byron Road (Co Rd 19A), and Cockram Road, included in Water District No. 7, within an agricultural district:

(1) The only land and/or structures which will be allowed to connect to the proposed waterline or sewer within an agricultural district will be existing structures at the time of construction, further agricultural structures, and land and structures that have already been approved for development by the local governing body prior to the filing of the Final Notice of Intent by the municipality.

Land and structures that have been approved for development refer to those properties/structures that have been brought before a local governing body where approval (e.g., subdivision, site plan, and special permit) is needed to move forward with project plans and the governing body has approved the action. If no local approval is required for the subdivision of land and/or the construction of structures, the municipality accepts the limitation under Public Health Law §1115 that defines a "subdivision," in part, as "any tract of land which is divided into five or more parcels." Water and/or sewer service will not be extended to the fifth and subsequent parcels where no local approval is required and the land is located within a county adopted, State certified agricultural district.

(2) If a significant hardship can be shown by an existing resident, the lateral restriction to the resident's property may be removed by the municipality upon approval by the Department. It is the responsibility of the resident landowner to demonstrate that a hardship exists relative to his or her existing water supply or septic system and clearly demonstrate the need for public water or sewer service. The municipality shall develop a hardship application to be filed with

the municipality, approved by the County Department of Health, and agreed to by the Department of Agriculture and Markets.

- (3) If it can be demonstrated to the Department's satisfaction that the landowner requested the county to remove his or her land from an agricultural district at the time of district review and the county legislative body refused to do so, lateral restrictions may be removed by the municipality if the Department determines that the removal of the restriction for the subject parcel(s) would not have an unreasonably adverse effect on the agricultural district.
- (4) If land is removed from a county adopted, State certified agricultural district and the district has been reviewed by the county legislative body and certified by the Commissioner for modification, lateral restrictions imposed by the municipality are no longer in effect for the parcels of land that have been removed from the agricultural district.
