•**Health Insurance:** Supervisor Yasses and Councilman Thompson met with the union employees and it was mutually agreed that the Town would change the health insurance coverage for Town employees from Univera ValUcare Plus Silver 4 to BCBS of WNY Gold PPO 7100 HSAQ. Beginning August 1, 2016 the Town will contribute \$1,300 into each HSA account. Up to and including December 31, 2016, after using all of their \$1,300 deductible, active and retired employees can submit for repayment of copayments up to \$900. The union and the Town will negotiate the benefit for 2017 and future years.

Justice Grant: Justice Smith would like an additional camera at the bench for the Judge's viewing, an electronic gate opener for the Judge and court clerk to park in the back of the building, safety shield for the judge's bench and a hand held metal detector. Grant needs to be in by October 1st.

BULK MUNICIPAL WATER APPLICATION:

The Town Attorney advised the board that they can add an addendum to the Request Form stating that there shall be no mixing of chemicals directly form the Town facilities or on Town property. The Town Board agreed this was the best solution and that this wording should be included on all future forms.

A <u>motion</u> was made by Supervisor Yasses to approve the Bulk Municipal Water Request from Helena Chemical Company, Inc. for the purchase of bulk water from the Town of Byron, with the addition of the following wording: It shall be agreed between the parties that the foregoing Agreement is hereby amended as follows: There shall be no mixing of chemicals directly from the Town facilities or on Town property. The motion was seconded by Councilman Thompson and carried with the following vote:
