  - ·MRB Group would assist the Town through the Article 10 process
- ·Host Agreement usually last for the life of the project. Right now payments are running from \$1,000-\$1,500 per megawatt
  - ·MRB Group has an economic development department
- ·The Town should be thinking about retaining an attorney to assist in the Article 10 process, whether it's Paul Boylan or another attorney
- After some discussion regarding the necessity to hire an attorney to assist the Town through the Article 10 process, it was agreed by the Board that the Supervisor would contact Paul Boylan with the list of attorney names he receives from MRB Group, and have Paul Boylan contact them to see if they can come to a Special Town Board meeting on September 4<sup>th</sup> at 7:00 p.m.



# Developer NextEra Energy Resources

### Basic Background

280 mW solar rating

20 mW/4-hour energy storage

Project Area 3,418 Acres (1,500 – 2000 acres for solar energy center)

Article 10 - applies electric generating facilities with generating capacity of 25 mW or more.

Siting Board - oversees Article 10 process

2 Ad Hoc members (recommended by Town and County)

Public Involvement Program (PIP) Plan - Submitted April 24, 2019

2 Open Houses to be held

#### **Pre-Application Phase**

Preliminary Scoping Statement (PSS) - at least 150-days after PIP and 90-days before Application Outlines project in detail (environmental/health impacts, identifies proposed studies, alternatives, local, state and federal requirements) - earliest date is Sept. 23, 2019

Must be provided to state local municipalities, libraries, etc.

Notice must be published in local paper

Public Participation

Intervenor Fund (Pre-App Phase)

To hire expert witnesses, consultants, lawyers, etc. make stipulations on PSS to contribute to a complete record.

Half the funds must go to the municipal parties & half to local parties

\$350/mW (up to \$200,000)

This Project =  $$350/mW \times 280 mW = $98,000$ 

Half to Byron = \$49,000

#### **Application Phase**

Complete all items identified in the Pre-Application

Filed with the Siting Board



Available for public inspection Provided to interested parties

Intervenor Fund (App Phase) \$1,000/mW (up to \$400,000)

This Project =  $$1,000/\text{mW} \times 280 \text{ mW} = $280,000$ 

Half to Byron = \$140,000

#### **Administrative Hearing**

Siting Board sets within 60-days of receipt of complete application

Identify intervenors, awards intervenor funds, and establishes a case schedule

#### Siting Board Decision Phase

Reviews all application materials and makes findings on: impacts (environmental, electrical capacity, etc.), compliance with state laws and regulations, compliance with or override unreasonably restrictive local laws.

Compliance Phase

Pre-Construction – filing plans, permits, approvals

DPS - On-site Compliance - staff on hand to ensure compliance requirements are met Long Term Compliance - Certificate may require long term compliance and decommissioning, etc.
