# Plan Background

- \* Adopted by the Genesee County Legislature in 2001
- \* Identified as a mitigating action to the impacts of the County Water Project under SEQR (State Environmental Quality Review Act)
- \* Reviewed every 3 years (or at the request of the Legislature)

### Objectives of the Plan

- \* Focus and encourage economic growth in areas with available public services
- \* Revitalize city, village and hamlet business districts and neighborhoods
- \* Protect farmland and reduce impacts upon agricultural activity

### Smart Growth Beyond Genesee County

\* Smart growth is a better way to build and maintain our towns and cities. Smart growth means building urban, suburban and rural communities with housing and transportation choices near jobs, shops and schools. This approach supports local economies and protects the environment.




## Principles Of Smart Growth

- Foster strong, sustainable businesses in community centers: enhance infrastructure in downtowns and villages to attract economic growth and discourage scattered development
- 2. Preserve open space, forests, farmland, natural beauty, and critical environmental areas - keep irreplaceable resources intact to bolster local economies, improve quality of life, and guide growth inward
- Strengthen and direct development towards existing communities tap into existing infrastructure and neighborhood resources to stop the sprawling urban fringe
- 4. Foster distinctive, attractive communities with a strong sense of place value development and construction that has distinctive architectural beauty
- 5. **Create walkable neighborhoods** build compactly and focus everyday activity along streetscapes designed for pedestrians, bicyclists, transit riders, and automobiles
- Take advantage of green building design use innovative approaches, proper building placement, and local materials

### Principles Of Smart Growth

- Create a range of housing opportunities and choices build quality housing for people of all income levels with access to jobs, culture and open space
- 8. Encourage community and stakeholder collaboration in development decisions work together to find creative solutions, increase community understanding and plan and invest in shared spaces
- 9. **Mix land uses** locate commercial uses proximate to residential areas and open space
- 10. Make development decisions predictable, fair and cost effective provide government leadership that creates a fertile environment for innovation
- 11. **Provide a variety of transportation choices** reinforce the viability of smart growth with efficient movement between housing, shopping, and jobs
- 12. **Foster long term comprehensive planning** plan to reach local, regional and state goals, to target investment, increase local capacity and increase intergovernmental efficiency



- Smart Growth Cabinet created in 2007
- \* Cabinet consists of representatives from all State agencies that affect land use
- \* Incorporate the principles of smart growth into all relevant state plans, policies and programs that affect land use and development outcomes
- \* Create a policy agenda for promoting and incentivizing smart growth.

# Scope of the Genesee County Smart Growth Plan

- \* Established the development area map that identifies key areas for future growth
- \* Provides examples of zoning techniques for local communities to adopt if they desire
- \* Encourages growth in the most appropriate areas through hook ups to the County Water System
- \* Directs future County resources to development areas

# Priority Development Areas

- \* Areas of the County that contain available lands and public infrastructure needed to support sustainable development
- \* Includes areas where future infrastructure could be affordably provided
- \* Avoids Agricultural Districts and environmentally sensitive areas, such as wetlands, wildlife habitats and flood hazard areas

## Reserved Development Areas

- \* Second classification of development area
  - \* Specific areas
  - \* Adjacent to a Priority Development Area
  - \* Promising for near future development
  - \* Can proceed without the need to analyze the Smart Growth Plan when a review has not been scheduled
- \* If certified, function as priority development areas
- \* For certification, certain conditions are imposed on the Town

## Genesee County Water System Hookups


- \* Within Priority Development Areas or in certified Reserved Development Areas
  - \* All new and existing development are automatically entitled to hook-up (subject to lateral restriction policies adopted by local municipalities for land within Agricultural Districts)

# Genesee County Water System Hookups

- \* Outside Priority Development Areas or in non-certified Reserved Development Areas
  - \* Automatically entitled to hook-up into the County water system if:
    - \* Structures for which a building permit has been granted as of the date the Smart Growth Plan is adopted or amended by the County Legislature
    - \* All existing and new agricultural uses
  - \* Other Hookup Applications must get approval from the Administrative Review Committee


# Reserved Development Areas Conditions for Certification


- The area is identified in the local Comprehensive Plan.
- \* Smart Growth principles are implemented in this area by form-based regulations (such as Green Genesee Smart Genesee model).




# Byron and Smart Growth


- \* Smart Growth applies per the water agreement between the Town and the County.
- \* Applies to County-funded portions of the County's water system include all water lines that are constructed by the County, financially subsidized by the County, or supplied with water from a source built or subsidized by the County.
- \* Town of Byron's Water District #1 is exempt unless reconfigured.


































## Next Steps
