LEGAL NOTICE SPECIAL MEETING TOWN OF BYRON

PLEASE TAKE NOTICE, that the Byron Town Board will hold a Special Meeting on Wednesday, September 18, 2019 at 7:00 p.m. at the Byron Town Hall, 7028 Rte. 237, Byron, New York. The purpose of the Town Board meeting will be to discuss the engagement of co-counsel to act on behalf of the Town in

conjunction with the Town Attorney, representing the Town before the Article 10 Siting Board and related matters. Secondly, hiring a technical consultant/engineering firm to advise the Town regarding technical matters related to the Article 10 proceeding with regard to Excelsior Energy Center. Also, to consider a Local Law amending the Zoning Ordinance in regard to solar energy facilities.

Debra Buck-Leaton Byron Town Clerk

Town Attorney Paul Boylan – The first subject to come before the Town Board is the engagement of co-counsel to act on behalf of the Town in conjunction with the Town Attorney. Paul would recommend that the Town Board hire the Zoghlin Group from Rochester to act as co-counsel to act on behalf of the Town in conjunction with the Town Attorney. They have worked on 2 wind projects and are representing the Town of Rush in the Caledonia solar project.

The second subject to come before the Town Board would be to hire an engineering group. Paul would recommend that the Town Board hire MRB Group because they're familiar with the Town, have worked on other solar projects, and are extremely qualified.

A <u>motion</u> was made by Councilman Klycek to hire the Zoghlin Group to act as cocounsel to act on behalf of the Town in conjunction with the Town Attorney, representing the Town before the Article 10 Siting Board. Also, to hire MRB Group as a technical consultant/engineering firm to advise the Town regarding technical matters related to the Article 10 proceeding with regard to Excelsior Energy Center. The motion was seconded by Councilman Thompson and carried with the following vote:

Vote: Ayes: 3 Abstain: 1 (Councilwoman Fuller)

The last subject to be discussed is to consider a Local Law amending the Zoning Ordinance in regard to the solar energy facility. The current Town law 11.15 states that Solar Energy Systems are permitted in the Town (2013). The Excelsior Energy project would probably not be impacted by a Zoning Law change now, but it will state where the Town stands with regard to setbacks, etc.

Supervisor Rouse – he would like to send it to the Planning Board for review.

A <u>motion</u> was made by Councilman Klycek To have the Planning Board consider amending the zoning ordinance in relation to the solar project, and to come back to the Town Board to give a recommendation. The motion was seconded by Councilman Thompson and carried with the following vote:

Vote: Ayes: 3 Abstain: 1 (Councilwoman Fuller)

There was a discussion regarding land values, the Article 10 process and Town Zoning Laws. Resident concerns were heard.

Keddy Chandran – Studies have shown that there aren't meaningful negative impacts to property owners. They are at the beginning of the process and are meeting with adjacent landowners to address concerns. Their goal is to do more than what the Zoning Law requires. The Preliminary Proposal is being filed on September 23rd.
