WHEREAS the Town of Byron intends to submit an application to the New York State Office of Homes and Community Renewal for funding under the Community Development Block Grant (CDBG) Program for the 2025 program year; and

WHEREAS, the State of New York has announced that up to \$24.2 million is available through the 2025 CDBG Program, with up to \$20 million specifically available for public infrastructure projects; and

WHEREAS the Town of Byron is considering submitting an application for up to \$2 million in CDBG funds to support the Waste Water Treatment Project and

WHEREAS, as part of the application process, the Town of Byron must hold a public hearing to gather input from citizens, public agencies, and other stakeholders on the proposed CDBG application, community needs, and CDBG funding priorities.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Byron Town Board hereby schedules a public hearing to be held on July 9, 2025 at 6:30 pm prior to the regular Town Board meeting to receive public comments on the Town's proposed CDBG application for the Waste Water Treatment Project and

RESOLUTION OF SUPPORT FROM THE TOWN OF BYRON 2025 WATER QUALITY IMPROVEMENT PROJECT, CONSOLIDATED FUNDING APPLICATION WASTEWATER TREATMENT PLANT IMPROVEMENTS

WHEREAS, the Town Board for the Town of Byron, located in Genesee County, supports the submission of a 2025 Department of Environmental Conservation Water Quality Improvement Project application through the Consolidated Funding Application for upgrades to the wastewater treatment facilities; and

WHEREAS, the New York State Department of Environmental Conservation (DEC) provides a competitive statewide reimbursement grant program for local governments, administered to directly address documented water quality impairments; and

WHEREAS, an Engineering Report entitled Preliminary Engineering Report for the Wastewater Treatment System Improvements, recommends implementing the Project to help improve water quality and protect public health; and

NOW THEREFORE BE IT RESOLVED, the Town of Byron Town Board identifies the Town Supervisor as the authorized representative of the Town to execute necessary documents relative to and as required for the grant application; and

BE IT FURTHER RESOLVED, the Town Board does hereby accept that they shall provide at least 25% match of the total of any grant funding awarded, as a local match are hereby appropriated in the form of in-kind services, cash contributions and obligated from the sewer fund or SRF financing in accordance with the Bond Resolution; and

BE IT FURTHER RESOLVED, that the Town Board for the Town of Byron, located in Genesee County, recognizes and fully supports the submission of the 2025 Water Quality Improvement Project application by MRB Group on behalf of the Town to improve water quality and protect public health.

- -Councilman Thompson asks Supervisor Hensel what is being done with the three homes that are located in the town of Stafford that were hooked up by Monroe County Water Authority. He recalls an agreement being drawn up but it seems the town of Stafford denied signing it. He also states he spoke with Scott Mattison from MRB whom gave examples of what to do in cases like this so they can be added in on the debt service.
- -Supervisor Hensel states she is not the attorney and does not know the status
- -Councilman Thompson states the town board was unaware that Stafford refused to sign the

agreement. He asks why the board was not notified that there was an issue. He states if they had known they could have taken action last year

- -Supervisor Hensel states she doesn't have an answer for that. The attorneys and the engineers were involved she doesn't know why it wasn't taken care of by the attorney
- -Councilman Thompson states again the board should have been made aware of what was going on
- -Supervisor Hensel states she's sorry and I guess you can take it up with the attorney and see what type of recourse can be taken
- -Councilman Thompson asks if that can be added to the executive session discussion
- -Supervisor Hensel states yes, that falls under the litigation subject
- -Supervisor Hensel states she dropped the ball she thought the people we pay to do things took care of it
- -Councilman Thompson states they did take care of drawing up the agreement. When Stafford refused to sign the board should have notified. He states he will pose the question to Paul Boylan what we can do now

SOLAR PROJECT UPDATES:

Excelsior- Complaint process is on the website for review email and phone are the preferred method of contact. There are 41 retention ponds only 11 will be permanents. The DEC requested these be done to help any flooding possibility. The decommissioning plan that was signed in 2022 it is being executed now by Excelsior. There is a 21 day period to ask any questions and get that published. Supervisor sates she forwarded it off to MRB and the town attorney for review this afternoon.

Leatherleaf- Not permitted yet

Blue Wave- Special use permit has been given

Green Street- Not hooked up yet but built. There is an issue with National Grid

SHORT TERM RENTAL MORATORIUM DISCUSSION:

- -Per Genesee County there is no review required for the short term rental moratorium because the moratorium is being requested for less than one year
- -Supervisor Hensel states she recuses herself from voting because she did at one point have short term rentals
- -Councilman Dilcher states his feeling on the short term rentals is that he does not want to stop people who already have plans in place with their short term rentals. He suggests moving forward the topic be put in the zoning laws to monitor for safety
- -Councilman Thompson states the topic should be tabled because there were only two people able to vote on the topic

REPLACEMENT OF COUNCILMAN KNICKERBOCKER:

- -The town board received four applications for the open board position. The board chose to interview on their own
- -Supervisor Hensel states she sent a questionnaire to all who applied and received two back. She

also states two of the applicants were in attendance. She asked if each applicant wanted to tell the board why they were interested in the position

- -Brandon Mason stated he was interested in the position because he saw it as way to get involved in the community. Living here with his wife and two small children he sees it as an investment. Also to help guide and be a cog in the wheel that steers the future of our town because it is worth investing in
- -Barbie Starowitz states that with her bus business and being around in the community she would bring back good and bad things she hears that are happening in the community. She would ensure that my voice and others would be heard. She stated that the supervisor was the only one who reached out to her to ask questions.
- -Supervisor Hensel asked each applicant if it was their intention to run for the position in the November election.
- -Brandon Mason states he is running in the November election
- -Supervisor Hensel states she was under the impression Barbie Starowitz only wanted to sit on the board through December
- -Barbie Starowitz confirms that her intention was not to run in the upcoming November election

- -Town Clerk received two quotes for new software regarding sewer billing
 - a. Edmunds Gov Tech (what is used currently)-One year investment- \$6,100.00 Annual Cost- \$2,100.00
 - b. Williamson Law Book Company- One year investment- \$8,325.00 Annual Cost- \$2,000.00
- -The town clerk would like approval to sign the agreement with Edmunds Gov Tech for the sewer billing program moving into 2026.
- -Town clerk states staying with Edmunds makes sense because having access to the history of the accounts is an added benefit as well as the program having the capability to grow with our needs
- -Supervisor Hensel asked if the clerk could look into if a cheaper program to use
- -Fireman's park bathrooms- In the past a member of the parks committee or the gatekeeper has kept the bathrooms cleaned. Since there is no gatekeeper for the season and the bathrooms need to be cleaned for the summer recreation program and for renters of the pavilion the clerk approached the current town cleaner to see if she could take on the responsibility of cleaning the bathrooms once a week for the next twelve weeks.

- -Lori Vogt the town's cleaner stated she would be able to clean the bathrooms through the season for an additional \$25.00 (twenty-five dollars) per week which is an additional \$300.00 for the 12 weeks of service added to her salary.
- -Supervisor Hensel asked if this job should be bid out to the public
- -Councilman Dilcher stated that no one is going to do it cheaper than that and Lori is already on staff it makes sense for her to do it if she is willing

She stated when the upstairs went from an apartment to a boarding house that those followed all the guidelines that were required.
- -Barbie Starowitz states when she grew up there were seven individuals in the household if we are going to go by what Pete says then are we charging per person for the sewer
- -Pete Yasses states no, that is not what he is saying. That is considered a families resident not a business
- -Darla Barnum asks Supervisor Hensel how many bathrooms are in the building
