Public Hearing – Blue Wave, LLC - Bergen Swamp Solar Farm Proposal

MOTION: A motion was made to continue the Public Hearing for the Blue Wave, LLC – Bergen Swamp Solar Farm Proposal by L. Bestehorn. Second by L. Tuerk. All in favor. None Opposed MOTION PASSED

Joeseph Graves (Blue Wave), Gabriella (Blue Wave), Evan Young (C&A) discussed the revisions to the project.

Screening options using evergreens, maples and a mix of evergreens, dogwoods, and cedar tree. Simulations of all options were shown at 5 years, 10 years, and 15 years as well as a leaf-on and leaf-off visual simulation of each. Site plans currently use a mix of evergreens and shrubs.

No questions or comments from the board.

Q: Candace Hensel – what is planned usage of the land between the road and setback of the screening array.

A: This will continue to be used as agricultural.

Q: Yvonne Loewke – were the same type of shrubs used for each the maple and evergreen simulations?

A: Yes, the same type of shrubs used in both.

Q: Yvonne Loewke – How can you guarantee that these trees will grow and survive in this area?

A: Maintenance plans are in place to monitor the growth of these plants.

Q: Yvonne Loewke – who is accountable for the maintenance of these plants.

A: Blue Wave Solar, LLC would ultimately be responsible.

Q: Mike Loewke – Will these be planted on a berm?

A: These are intended to not be planted on a berm.

Q: Shirley VonBergen – Behind our home, there is quite a rise in land. This will expose the solar panels at all times of year.

A: This is a unique vantage point. Accommodation will be made to screen this view, including a green mesh fence around the parameter. Can certainly consider the planting of larger trees in this area.

Q: Barbie Starowitz – can we review landscaping notes, construction notes, demolition notes, maintenance notes right now for discussion?

A: All notes are in the O&M plan and on file with the town. There is a copy on hand for review.

Engineer, Evan Young, walked through the landscaping plan with the board and public.

Q: Chairman Hilbert – After 25 years, will all the trees be removed as well?

A: Yes, that is currently in the plan per the comments from the town engineer.

Q: Yvonne Loewke – If Bergen Swamp, LLC goes belly up, does Blue Wave, LLC step up and take responsibility.

A: Blue Wave, LLC is the parent company and is ultimately responsible for the O&M Plan. There is also a bond issued by Blue Wave, LLC on the project.

Q: Barbie Starowitz – will the sheep be able to eat the types of grass that are being planted?

A: The Solar Grazers of America worked with the seed company to create the type of grass seed that will be used on this project. Solar Grazers of America are made up of over 1000 sheep farmers across the country.

Q: Barbie Starowitz – Will local sheep farmers be hired for the maintenance?

A: Blue Wave Solar, LLC will utilize the closest and most available companies using a map available through the Solar Grazers of America.

Evan Young walked through their response to the comments that were received from various sources. All comments have been addressed.

Joe Graves, Blue Wave Solar, LLC, walked through the process to get connected with National Grid and answered questions surrounding this.

Q: Steve Hohn – Who determined this as wetlands?

A: Diehlux Environmental Consulting – wetland consulting specialist

Q: Mike Loewke –The town is currently at 30% saturation of solar projects in the town of Byron. When will this end?

A: It is on the agenda for tonight's meeting.

No other questions or comments at this time.

The board gave their opinion of the types of trees and shrubs that are appropriate.

Q: Roger Rouse – These types of trees would not offer the same type of snow baffle that the evergreens would.

A: There is no issue with this in this area.

Q: Joel Woodward – What is the penalty if this property is not maintained?

A: This would be up to the town code enforcement. Measures have been provided for them to be penalized in the site plans.

L. Bestehorn will take this information back to soil and water and get their opinion on the types of trees being used, the sheep grazing, and amount of prime soil that is being used in this project. She will share their comments with the board.

J. Graves requested that any comments be received prior to the next meeting be addressed prior to that meeting.

Q: Dick VanBergen – Does the planning board have the power to object this project in its entirety?

A: Yes

Crawford & Associates Engineering firm is prepared to revise the plan to utilize the maple trees and other shrubs as opposed to the evergreens. The board would also like the group to utilize additional screening behind VanBergen's property in addition to/in place of the green mesh fence.
