Continuance of use of property. In 1992, the board had approved of the property to be turned into an adult entertainment business. This is not in an industrial zone, it is less than 500 ft from the

nearest resident, less than 200 feet from the nearest place of worship, not enough parking for the occupancy of 100 people.

Occupancy rating of 60 people, the second floor not occupied. This would require 30 parking spaces. The building is not handicapped accessible. A sprinkler system was requested several years ago, that the board is still waiting on.

Comments from Town Attorney, John Sansone:

The board will need to research the previous code/zoning updates.

Are there any meeting minutes requesting a sprinkler system? Was it legal at the time of operation. How long has the business ceased operation?

Is there anything in the town code as to how we handle nonconforming use?
